Dear Ms. Hinkley:

Your company submitted a formal request, dated October 3, 2016, to the Product Evaluation Board (PEB) of the Alabama Department of Transportation to update our records to reflect the new company name and to have dual listings for the above referenced products previously approved. Based on the review performed to confirm this request, the PEB approved the noted changes.

These five approved products manufactured under the name Powers Fasteners on *List II-15, Concrete Anchoring Systems*, of the Department's List of Qualified Materials, Sources and Devices will be revised to include the new parent company name, DEWALT, and to have additional DEWALT anchor brand names referenced. This dual product listing will be upheld until **August 31, 2018** to allow time for your rebranding process to be completed. After August 31, 2018, only the approved DEWALT brand products will be listed.

As a requirement to remain on a list you must provide only approved products to the Department projects and promptly notify us through formal correspondence (i.e. company letter) of a company, product, and/or address name change, any changes in production of the product or alterations that may change the product chemically or physically. This will allow our listing to stay current and will prevent your product from being removed from the list due to out-of-date information or failure to adhere to the terms outlined above. In addition, we reserve the right to request samples for testing at our convenience and/or require the submittal of current test data from a certified/qualified testing laboratory for our review should the product fail to perform satisfactorily or if changes are made to the product after placement on our list.
